

## RULES OF STAYING CHILDREN IN THE KID'S CLUB «VESNA Kids»

1. Working hours of the kid's club:  
Monday - Sunday - from **8:00 to 20:00**; break - **13:00-14:00**; **17:00-18:00**.
2. «VESNA - Kids» club accepts children of age:  
- **from 0 to 4 years only accompanied by one of the parents (legal representative) and in the presence of a medical certificate. At parents may need to use a paid nanny service;**  
- **from 4 to 11 years - in the presence of medical certificate.**
3. No more than 20 children may be admitted to the playroom at a time to ensure the safety and individuality of each child.
4. Before visiting the game room, it is necessary to take the child to the toilet.
5. The mandatory condition for the child's admission to the playroom is to fill in one of the parents (legal representative) of the registration form, which indicates the time of arrival / departure of the child to / from the playroom, the contact phone of parents (legal representatives), in which case You can contact them as well as other relevant information about the child and parents (legal representatives).
6. When leaving the baby in the playroom, parents should remove their baby's outerwear, shoes and jewelry.
7. In order to maintain cleanliness and hygiene, **children should only be allowed in the changing room or in socks and dressed** in accordance with the temperature in the game room, taking into account the active play of children.
8. Tell the caregiver about your child's personality traits and interests.
9. It is forbidden to bring barbed-cutting and other objects that are capable of causing injury to the game room; hand luggage, food, drinks, toys, money, documents and valuables.
10. Please explain to the child that it is forbidden to push each other in the playroom, to rush and use physical force to resolve any issue; talk with the use of obscene words and gestures to anyone; make noise, interfere with rest for other children.
11. The Administration does not bear responsibility for lost or left unattended items.
12. When bringing a baby for the first time, do not leave it for a long time to help adapt to the new environment. The recommended stay in the game room is no more than 2 hours, but it is necessary to visit the baby after the first hour of stay.
13. Children who do not have clear signs of respiratory and other diseases transmitted by airborne drip or other contact can visit the playroom.
14. The administration shall not be liable for damages related to the deterioration of the health of the visitor, if it happened due to his acute or chronic illness.
15. It is forbidden to bring toys, equipment and play equipment from the territory of the game room.
16. Children are prohibited from leaving the playroom without the assistance of a representative of the Administration or parents (legal representatives).
17. In the case of behavior or development of the child, parents (legal representatives) are obliged to inform the game room administrator.
18. In the case of aggression or other specific behavior, the Administration reserves the right to terminate the child's stay in the playroom and to call the parents (legal representatives) ahead of schedule.
19. The person specified in the registration form shall be entitled to take the child out of the playroom by presenting the identification document and the registration form.
20. If after the end of the playing room the parents (legal representatives) have not removed the child from the playroom, the Administration has the right to contact the police for the search of the parents.
21. For intentional unlawful acts, as well as intentional damage to the property of the game room, damage to the life and health of third parties, committed by the child or his parents (legal representatives), parents (legal representatives) are responsible under the current legislation, including property liability for compensation to third parties of property damage, as well as damage to the life and health of third parties.
